Continuing Personal Guarantee

In consideration of the extension of credit to Applicant by Staub Metals Corporation ("**Staub**"), and as an inducement to Staub to continue to extend credit to Applicant, the undersigned (each a "**Guarantor**") jointly and severally, unconditionally guaranty the payment of any and all sums of money as are now, or at any time hereinafter may be owing to Staub by Applicant as a result of Staub's extension of credit, including attorneys' fees and costs which may be incurred by Staub to enforce this Guaranty and/or enforce its claims against Applicant.

Guarantor agrees to indemnify and hold Staub harmless from any loss, damage and expenses caused or arising out of default on the part of Applicant. Staub may proceed against each Guarantor without being required to first proceed against the Applicant and Staub may proceed against any one of the Guarantors without waiving its rights to proceed against any of the remaining Guarantors. Guarantor waives notice of the following: extension of time or modification of terms, settlements or resolutions or disputes, modification of credit line and default of Applicant.

Guarantor also waives any duty of Staub to disclose any facts Staub may now or hereafter know about Applicant, regardless of whether Staub has reason to believe that any such facts materially increase the risk beyond that which Guarantor intends to assume or has reason to believe that such facts are unknown to Guarantor or has a reasonable opportunity to communicate such facts to Guarantor. Guarantor agrees that Guarantor alone is fully responsible for being and keeping informed of the financial condition of Applicant and of all circumstances bearing on the risk of non-payment of any indebtedness hereby guaranteed.

Guarantor hereby waives: (i) all rights of subrogation, reimbursement, indemnification and contribution and any rights and defenses that are or may become available to Guarantor by reason of any provision of Sections 2787 through 2855 of the California Civil Code; and (ii) any rights or defenses Guarantor may have in respect of Guarantor's obligations as a guarantor hereunder by reason or any election or remedies by Staub.

This Guaranty shall constitute the entire agreement of Guarantor with Staub with respect to the subject matter hereof and no representation, understanding, promise or condition concerning the subject matter hereof shall be binding upon Staub unless expressed herein. There are no conditions to the full effectiveness of this Guaranty.

This is intended to be and is a continuing guaranty and shall include all present and future amounts owed by Applicant to Staub. This Guaranty shall not be revoked except by written notice to Staub not to make any further sales and deliveries on the security of this Guaranty and such revocation shall not be effective until the expiration of five (5) business days after such notice shall have been received by Staub by certified mail, return receipt requested. Any such revocation shall be effective only with respect to material shipped or delivered after the expiration of said five (5) business day period and shall not affect, in any respect, liability incurred by Guarantor prior to that date.

California law shall govern this Personal Guarantee.
